

Our priorities are determined through a collaborative process that involves listening to the ideas and experiences of our members. Our legislative task force and board of directors then transform these insights into actionable priorities, which go beyond simply taking a position on bills. This approach ensures that our organization's focus aligns with the collective aspirations of our membership and the construction industry.

TEXAS REGULATORY CONSISTENCY ACT - HB 2127

Rep. Dustin Burrows (HD-83) | Sen. Brandon Creighton (SD-4)

PASSED - Effective September 1, 2023

Brought regulatory uniformity and consistency to the state of Texas while asserting Texas' authority by prohibiting cities from adopting ordinances, resolutions, orders, or policies on certain matters.

- Establishes a more streamlined and efficient regulatory framework by promoting consistency across municipalities in Texas.
- Recognizes and provides support for unique challenges faced by small businesses.
- Creates a more business-friendly environment by reducing regulatory burdens, enhancing clarity, and fostering consistency in regulatory practices across the state.
- Allows for private entities (including associations) to bring a private cause of action against a municipality for an ordinance in violation of the law.

RIGHT TO REPAIR - HB 2965

Rep. Cody Vasut (HD-25) | Sen. Brandon Creighton (SD-4)

PASSED - Effective September 1, 2023

Defined statute to clearly state that Chapter 2272 of the Right to Repair Statute cannot be waived by contract.

- Lowered number of frivolous lawsuits happening after school bond projects were completed by allowing the opportunity for any potential defects to be remedied.
- ✓ Protects general contractors by disallowing governmental entities from circumventing this chapter by requiring the waiver of this statute in contracts.
- Promotes transparency and accountability in government projects by upholding the principles and objectives of the Right to Repair Statute.

NO DAMAGE FOR DELAY - HB 2265

Rep. Jeff Leach (HD-67) | Sen. Bryan Hughes (SD-1)

Passed the Texas House. Died in Texas Senate on Calendar

Prohibits Contractual language forbidding or limiting compensable damages for delays caused soley by the owner or its agent.

 Protects general contractors from being held financially responsible for delays caused soley by the property owner or their representative.

ABILITY TO ASSIGN TRUST FUND CLAIMS - HB 1864

Rep. Shelby Slawson (HD-59) | Sen. Bryan Hughes (SD-1) Passed the Texas House. Died in Texas Senate in Committee

Allows for the trust fund claim to be re-assigned to another party to the construction contract.

 Empowers general contractors and subcontractors by making the trust fund claim re-assignable and enhances legal remedies by allowing them to pursue individuals who have stolen money from projects.

INTERNATIONAL PLUMBING CODE - HB 2689

Rep. Cecil Bell (HD-3)

Died in House Committee on Licensing and Administrative Procedures

Would have declared International Plumbing Code as the sole plumbing code in Texas

- Reduced confusion among contractors, builders, and regulatory authorities by consolidating the plumbing code under one code (the International Plumbing Code).
- Saved on costs that come from the use of multiple plumbing codes.
- Enhanced efficiency in the construction process by establishing a clear and consistent set of regulations to follow as less than a dozen municipalities utilize the alternative, the Uniform Plumbing Code.

CHANGE ORDER LIMIT - HB 2854

Rep. Gervin-Hawkins (HD-120)

Died in House Committee on County Affairs

Increased the limit for change orders on government projects that required approval from the governing body.

- Increased current contract limit from \$1 million to \$5 million in recognition of inflation and labor challenges.
- Reduces administrative burden and delays by eliminating the need for repeated notices for public meetings and approvals by the governing body for contracts exceeding the change order limit.

PREVAILING WAGE CALCULATION - HB 2429

Rep. Geanie Morrison (HD-30)

Died in House Committee on State Affairs

Clarifies the use of acceptable alternatives to determine the prevailing wage of public projects.

WILLIAM TO THE REAL PROPERTY OF THE PARTY OF

- Allows for general contractors to utilize regional surveys from the Texas Workforce Commission in determining a prevailing wage.
- Applies to counties with populations of less than 1,000,000.

WAGE THEFT ORDINANCE - HB 3430

Rep. Briscoe Cain (HD-128)

Addressed through HB 2127

Asserts the state's authority in matters involving an alleged wage theft by pre-empting any local ordinance or enforcement of any local ordinance regarding wage theft.

PROJECT LABOR AGREEMENT LOCAL PROHIBITION - SB 936

Sen. Kelly Hancock (HD-9)

Passed the Texas Senate. Died on Texas House Floor

Expanded current statute to include a prohibition on the use of Project Labor Agreements (PLAs) on projects that receive funding from local government entities and expanded prohibition to include projects that receive local funding.

• Promotes equal opportunity for all contractors by ensuring they all have the same opportunity to participate in the bidding process, regardless of labor affiliation.

All priority bills advocated by ABC Texas that did not pass this session will be given priority in the upcoming 89th legislative session in 2025. We remain committed to advancing these critical initiatives and will actively work toward their successful passage, ensuring that the interests and concerns of our members are effectively addressed in the legislative process.

Bills Affecting the Construction Industry

Along with our own priorities, ABC Texas diligently tracked and monitored bills that might affect the construction industry. The following are bills that passed this session that may affect the construction industry.

ECONOMIC DEVELOPMENT INCENTIVES - HB 5

PASSED - Effective September 1, 2023

Rep. Todd Hunter (HD-32) | Sen. Charles Schwertner (SD-5)

Relating to agreements authorizing a limitation on taxable value of certain property to provide for the creation of jobs and the generation of state and local tax revenue; authorizing fees; authorizing penalties.

- This bill creates the successor to the previous economic development incentive program (Chapter 313) that expired at the end of 2022.
- Provides for tax incentives on certain business projects in exchange for capital investment and jobs.
- The Comptroller is tasked with developing administrative rules for the program, and those will go into effect on January 1, 2024.

BUSINESS TRIAL COURT - HB 19

PASSED - Effective September 1, 2023 unless otherwise noted by the bill.

Rep. Andrew Murr (HD-53) | Sen. Bryan Hughes (SD-1)

Relating to the creation of a specialty trial court to hear certain cases; authorizing fees.

- Creates a new specialty business court with statewide jurisdiction over non-insurance business contractual disputes where the disputed amount is over \$10 million.
- Judges will be appointed by the Governor and confirmed by the Senate to serve two-year terms and must meet certain requirements including 10 years of specialized experience.
- Applies to civil actions brought on or after September 1, 2024.

WORKERS' COMP CONTRACT LIMITS - HB 679

PASSED - Effective September 1, 2023

Rep. Keith Bell (HD-4) | Sen. Charles Schwertner (SD-5)

Relating to limitations of the use of workers' compensation insurance experience modifier values in soliciting and awarding public construction contracts.

• Prohibits the use of insurance experience modifiers in public and private construction

LONE STAR WORKFORCE FUND - HB 1755

PASSED - Effective September 1, 2023

Rep. Angie Chen Button (HD-112) | Sen. Carol Alvarado (SD-6)

Relating to the creation of the Lone Star Workforce of the Future Fund.

WILLIAM TO THE TRANSPORT OF THE PARTY OF THE

• Established a fund managed by the Texas Workforce Commission to provide grants for technical training programs.

CERTIFICATE OF MERIT FIX - HB 2007

PASSED - Effective September 1, 2023

Rep. Armando Martinez (HD-39) | Sen. Tan Parker (SD-12)

Relating to a certificate of merit in certain actions against certain licensed or registered professionals.

 Addressed the unintended consequence left from the 2019 legislative session on designbuild projects, where the design professionals are often on the same team as the contractors. This created a dilemma by forcing some parties to admit liability (by getting a "certificate of merit" against their own team member) in their efforts to deny liability which created insurance coverage issues.

CONTRACTOR PROTECTIONS ON GOVERNMENT OWNED PROPERTY - HB 2518

PASSED - Effective September 1, 2023

Reps. Keith Bell (HD-4) | Sen. Robert Nichols (SD-3)

Relating to required lease terms for public property leased to a nongovernmental entity; creating a criminal offense.

- Adds additional protections for contractors and suppliers whose labor and materials are used for newly built improvements on public property that has been leased to a private entity.
- Requires that additional language be included in the lease agreement between a governmental entity and a private entity.
- This includes language that specifies that any construction on the leased property must be bonded and that the lessee must notify the governmental entity before construction begins so that the governmental entity may have an opportunity to verify the bonds.

CONTRACTOR WORK OPT-OUT - HB 3485

PASSED - Effective September 1, 2023

Reps. Keith Bell (HD-4) | Sen. Nathan Johnson (SD-16)

Relating to a contractor's or subcontractor's right to elect not to proceed with additional work under a contract.

WITH THE PARTY OF THE PARTY OF

- Allows a contractor to elect not to proceed with additional work directed by a
 governmental entity if: the contractor has not received a fully executed change order for
 the additional work; and the aggregate or anticipated value of the additional work plus
 any other outstanding additional work requests exceeds 10% of the original contract
 amount.
- Also clarifies that a contractor who elects not to proceed with additional work directed by an owner or governmental entity is not responsible for damages associated with the choice not to proceed.

CRIMINAL RECORD ACCESS - HB 4123

PASSED - Effective June 13, 2023

Rep. Ryan Guillen (HD-31) | Sen. Judith Zaffirini (HD-21)

Relating to access to and use of certain criminal history record information.

- Aligns state law to comply with the new requirements established by the Federal Bureau of Investigations (FBI) for conducting criminal background checks for employees as well as contractors.
- The bill applies broadly across dozens of industries, including construction.
- For contractors, there is a new requirement for contractors who may be working in schools and near children. The bill creates a new designation known as a "qualified school contractor."
- The Department of Public Safety (DPS) and Texas Education Agency (TEA) will be developing rules together which will establish the formal process for contractors to comply.

CAREER INVESTIGATION EXCUSES - SB 68

PASSED - Effective May 24, 2023

Rep. Andrew Murr (HD-53) | Sen. Judith Zaffirini (SD-21)

Relating to excused absences from public school for certain students to visit a professional's workplace for a career investigation day.

WITH THE TAXABLE OF THE PROPERTY OF THE PROPER

- Act allows school districts to excuse students from attending school for a career investigation day, where they can visit a professional's workplace to explore a potential career field.
- Students can be excused for up to two days during their junior year and two days during their senior year, as determined by the school district's policy and procedures.
- Additionally, students whose absences are excused for career investigation days cannot be penalized, and their attendance will be counted for calculating the average daily attendance. It is also mandatory that students will be given reasonable time to make up any missed school work.

COURT EXPANSION: 15TH APPELLATE - SB 1045

PASSED - Effective September 1, 2023

Rep. Andrew Murr (HD-53) | Sen. Joan Huffman (SD-17)

Relating to the creation of the Fifteenth Court of Appeals with jurisdiction over certain civil cases, the compensation of the justices of that court, and the jurisdiction of the court of appeals in this state.

 Creates a new appellate court (the 15th Court of Appeals) with exclusive jurisdiction over cases involving the state, designated state agencies, their officers or employees, constitutional challenges to state statutes or rules with the involvement of the attorney general, and other matters as determined by law.



88TH LEGISLATIVE SESSION AWARDS

At the end of every legislative session, the Board of Directors for ABC Texas recognize certain legislators who supported our priorities or went above and beyond on a specific issue. There are two award categories:

- **Free Enterprise Champion**-Recognizes legislators who went above and beyond to defend the merit-shop construction industry and Free Enterprise (this is limited to no more than two Senators and no more than three House members).
- **Legislative Champion**-Recognizes legislators who supported our priorities and worked with us on improving legislation (no limit on number of awards).
